

 The question is how we are to construe the pronoun huwa in the original. The alternative translation would be: OTo each is a goal to which he turns.O

The simile of life being a race in which we all zealously run forward to the one goal, viz., the goal of good may be applied individually and nationally. This supplies another argument of the KaOba Qibla, viz., the unity of goal, with diversity of races, traditions and temperaments.

2. The simile of a race is continued, and so the Qibla command is repeated from that point of view. In ii. 144 it was mentioned as the new symbol of the new nation (Muslim) now it is shown as the symbol of Good, at which we should all aim, from whichever point we started, e.g., as Jews or Christians, or our individual point of view; the Qibla will unite us as a symbol of the Goal of the Future. In ii.150 below, it is repeated: first for the individual, on the ground of uniformity and the removal of all occasions of dispute and argument;


and secondly for the Muslim people on the same ground, as a matter of discipline. There is another little harmony in the matter of the repetitions. Note that the race and starting point argument begins at ii. 149 and is rounded off in the first part of ii, 150; while national and general argument beginning at ii. 144 is rounded off in the latter part of ii. 150. The latter argument includes the former, and is more widely worded: Owheresoever ye areO: which in the Arabic expression would imply three things; in whatever circumstances ye are, or at whatever time ye are, or in whatever place ye are. I have spoken before of a sort of musical harmony in verbal repetitions: here there is a sort of pictorial harmony, as of a larger circle symmetrically including a smaller concentric circle.

- 3. This verse should be read with ii. 150. of which the sentence is here completed. The argument is that in the grant of the KaÖba Qibla. God was perfecting religion and fulfilling the prayer /or the future made by Abraham. That prayer was threefold: (1) that Mecca should be made a sacred Sanctuary (ii. 126); (2) that a truly believing (Muslim) nation should be raised, with places of devotion there (ii 128,; and (3) that an Apostle should be sent among the Arabs with certain qualities (ii. 129) which are set out there and again repeated here to complete the argument.
- 4. The word OrememberO is too pale a word for Zikr, which has now acquired a large number of associations in our religious literature, especially Sufi literature. In its verbal signification it implies to remember; to praise by frequently mentioning; to rehearse; to celebrate or commemorate; make much of: to cherish the memory of as a precious possession. In Sufi devotions zikr represents both a solemn ritual and a spiritual state of mind or heart, in which the devotee seeks to realize the presence of God. Thus there is zikr of the mind and; zikr of the heart. For beginners he one may lead to the other, but in many cases the two may be simultaneous. There is a subtler distinction, between the zikr that is open, and the zikr that is secret corresponding to the two doors of the heart, the fleshly and the spiritual. In English some account (very imperfect) of; zikr will be found in HughesÖs Dictionary of Islam, covering over 14 columns.

- From here on to ii 167 there is a great deal of mystic doctrine. That it is linked with the institution of the Qibla shows that the Qibla is itself connected with a great many root-ideas of the mystical interpretation of Unity.
- 5. An additional meaning implied in sabr is self-restraint. Haqqani defines it in his Tafsir as following Reason and restraining Fear, Anger, and Desire. What can be a higher reward for patience, perseverance, self-restraint and constancy than that God should be with us? For this promise opens the door to every kind of spiritual well-being.
- The Opatient perseverance and prayerO 6. mentioned in the last verse is not mere passivity. It is active striving in the way of Truth, which is the way of God. Such striving is the spending of oneOs self in GodOs way, either through our property or through our own lives, or the lives of those nearest and dearest to us, or it may be the loss of all the fruits of a lifetimeOs labour not only in eminently desirable in itself, but which we must cheerfully sacrifice if necessary for the Cause. With such sacrifice, our apparent loss may be our real gain: he that loses his life may really gain it; and the rewards of OfruitsO that seem lost were mere impediment on our path to real inward progress.

These extreme sacrifices must be made under the orders and instructions of a righteous Imam, who can see the whole field of spiritual and physical warfare and judge justly of their necessity. Otherwise there is no inherent virtue in mere sacrifice as such or when exercised at the whim of an individual. Courage (the resistance to the test of Fear) and Self-denial (the resistance to the test of Hunger or Desire), are also, if they are to be virtuous, subject to similar conditions.

 The glad tidings are the blessings of God in ii. 157 or (which is the same thing) the promise in ii. 153 that God will be with them.



CONCERNING THE COLLECTION OF CHARITY DOING GOOD DEEDS

(1027) Abu Huraira reported what AllahOs Messenger (SAW) had said: If anyone consumed a pair of anything for the sake of Allah(1), he would be invited to enter Paradise (with these words): O servant of Allah, it is good (for you). Those who were engaged in prayer will be invited to enter by the gate of prayer. Those who took part in Jihad will be invited to enter by the gates of Jihad. Those who gave charity will be invited to enter by the gates of charity; and those who fast will be invited to enter by the gate ar-Rayyan(2). Abu Bakr As-Sidik said: Messenger of Allah is it necessary that a person be invited through one of these gates? Will anyone be invited to enter by all those gates? The Messenger of Allah (SAW) said: Yes, and I hope you will be one of them (3).

(1027 R1) This hadith has been narrated by Zuhri through another chain of transmitters.

(1027R2) Abu Huraira reported what AllahÖs Messenger (SAW) said: He who spent a pair for the sake of Allah, the guardians of Paradise would call him, (in fact) every guardian of the door (of Paradise would welcome him saying): O, so and so, come on. Upon this Abu Bakr said: Messenger of Allah, (it means) there would be no distress on this person. The Messenger of Allah (SAW) said: I hope you would be among them.

(1028) Abu Huraira reported that the Messenger of Allah (SAW) said: who came to test among you today? Abu Bakr (Allah be pleased with him) replied: I am. He (the Holy Prophet again) said: Who among you followed a bier today? Abu Bakr (Allah be pleased with him) replied: I am. He (the Holy Prophet again) said: Who among you fed a poor man today? Abu Bakr (Allah be pleased with him) replied: I am. He (The Holy Prophet again) said: Who among you visited a sick person today? Abu Bakr (Allah be pleased with him) said: I am. Upon this the Messenger of Allah (SAW) said: Anyone in whom (these good deeds will certainly enter Paradise)(4).

EXHOSTATION TO SPEED (FOR THE SAKE OF ALLAH AND) DISAPPROVAL OF CALCULATING THE ARTICLES OF CHARITY)

(1029) Asma, daughter of Abu Bakr (Allah be pleased with him), reported: The Messenger of Allah (SAW) said to me: Spend(5), and do not calculate, otherwise Allah would calculate for you(6).

(1029R1) AsmaÖ reported what AllahÖs Messenger (SAW) had said (to her): Spend and do not calculate, (for) Allah would calculate for you; and do not hoard, otherwise Allah would withhold it from you.

(1029R2) This hadith has been narrated on the authority of AsmaÖ through another chain of transmitters.

(1029R3)Asma, daughter of Abu Bakr, reported that she came


to the Apostle of Allah (SAW) and said: Apostle of Allah, I have nothing with me, out only that which is given to me by Zubair (for household expenses). Is there any sin for me if I spend out of that which is given to me (by Zubair)? He (the Holy prophet) said: Spend according to your means; and do not hoard, for Allah will withhold it from you.

(103O) Abu Huraira reported what AllahÖs Messenger (SAW) had said: O Muslim women, no one for you should consider even a sheepsÖs trotter too insignificant to give to her neighbour.

EXCELLENCE OF GIVING CHARITY SECRETLY


(1031) Abu Huraira reported that the Apostle of Allah (SAW) had said: Seven are (the persons) whom Allah would give protection with His Shade on the Day when there would be no shade but that of Him (i.e. on the Day of Judgment, and they are): a just ruler, a youth who grew up with the worship of Allah; a person whose heart is attached to the mosques; two persons who love and meet each other and depart from each other for the sake of Allah; a man whom a beautiful woman of high rank seduces (him illicit relation), but he (rejects this offer by saying): Of fear AllahO. A person who gives charity and conceals it (to such an extent) that the right hand does not know what the left has given(7). And a person who remembered Allah in privacy and his eyes shed tears.



- It means two things. According to some of the tradition Abu
 Jharr Ghifari was asked to explain the meaning of the term
 ÖZaujainÖ used in this context, and he replied: Two horses, two
 slaves, two camels. The majority of the commentators of hadith is of
 the view that ÖZaujainÖ here means to give repeatedly and
 constantly.
- 2. This should not be taken to mean that the gate of prayer be only those who are engaged in prayer to the negligence of all other obligatory act. This is not the case. All these noble persons would not be neglecting from that very gate in which they were most interested. For example, one entering from the gate of Jihad would be saying prayers, observing fast giving Zakat and charity and performing Haji, but as he had been keenly interested in Jihad he would be admitted from that very gate. The word Oar-RayyanO, used for the gate of fast, is highly significant, it means well-watered or fresh and it has a meaningful relation with fast by observing which man feels thirsty during the day, and at the conclusion of it in the evening one feels satiated and fresh.
- It is a conclusive proof of the eminence of Hadrat Abu Bakr. He
 was a repository of virtues and all the noble qualities had been so
 harmoniously blended in his personality that it gave him a look of
 perfection from every side.
- It is not the single act or deed that makes the life noble and virtuous but the whole life lived with nobility and religious devotion that makes one a true Muslim.
- In text three words have been used. They all carry the same meaning.
- A Muslim should spend on good deeds cheerfully and generously.
- There has been some inadvertent alteration of words. The correct is: The left hand does not know what the right hand has givenO.

Appellate Division upholds bail to 5 top Jamaat leaders including Nizami, Sayedee and Mojaheed

appellate Division of the Supreme Court on 20 December upheld bail to Ameer of Bangladesh Jamaa-e-Islami and ex. Minister Maulana Motiur Rahman Nizami, Secretary General and former Minister Ali Ahsan Mohammad Mojaheed, Nayebe Ameer and former Member of parliament Maulana Delwar Hossain Sayedee, Assistant Secretaries General Muhammad Kamaruzzaman and Md. Abdul Quader Molla in five cases. The government appealed against the bail granted by High Court, During the hearing on 20 December Chamber Judge Justice Surendra Kumar Sinha gave ÖnoÖ order without issuing an order. Consequently an interim bail to the arrested 5 top Jamaat leaders granted by High Court upheld. Jamaat counsel senior lawyer Barrister Abdur Razzak informed the journalists that Chamber Judge of Appellate Division did not give order on the governmentOs appeal against the bail granted by High Court. Interim bail by the High Court remained upheld. On 28 November, 2010 a HC Division bench comprising Justice Mainul Islam Chowdhury and Justice AKM Abdul Hakim granted the six-month interim bail to 5 top Jamaat leaders. Alongside that it issued a rule to the concerned persons of the government asking the reason as to why they will not be granted a permanent bail. In the Court Senior Lawyer Barrister Abdur Razzak stood

for Jamaat leaders. He was assisted by Barrister Baleyet Hossain and Barrister Imran A Siddique. Additional Attorney General M K Rahman appeared for the government.

The police filed cases against Maulana Motiur Rahman Nizami, Ali Ahsan Mohammad Mojaheed, Maulana Delwar Hossain Sayedee, Muhammad Kamaruzzaman and Abdul Quader Molla on 20 June at Paltan police station, on 7 June at Airport police station, on 12 & 7 February at Paltan police station and on 30 June respectively. Police alleged that the 5 top Jamaat leaders obstructed police to perform their duties and carried out arson and vandalism during the general strike observed on 30 June.

The High Court granted an interim bail to 5 top Jamaat leaders. On 29 June Maulana Motiur Rahman Nizami, Ali Ahsan Mohammad Mojaheed and Maulana Delwar Hossain Sayedee, were arrested under the pretext of hurting the religious sentiment. Later police filed the case at the Paltan Police Station against these 3 top Jamaat leaders, on 14 July Muhammad Kamaruzzaman and Abdul Quader Molla were arrested from the gate of the Supreme Court in a case filed at Pallabi Palice Station in 2008.

MAQBUL URGES NATION TO BE UNITED AGAINST GOVTÖS ATROCITES

Acting Ameer of Bangladesh Jamaat-e-Islami Maqbul Ahmad categorically said that the present Awami League (AL) government was deadly misbehaving with the opposition parties according to its will bragging about power. But it should have a limit. They (AL) did not assume office forever. He also said the ruling party wants to make power everlasting by staging a farcical drama. The people of the country will never accept this farcical drama, he added.

Acting Ameer-e-Jamaat Maqbul Ahmad made this above observation while speaking at a discussion meeting and Dua Mahfil as chief guest on the occasion of the great Victory Day at Moghbazar Al-Falah auditorium on 16 December.

Presided over by Acting Ameer of Jamaat Dhaka City Hamidur Rahman Azad MP the meeting was also addressed by Acting Secretary General of Jamaat-e-Islami A T M Azharul Islam, Central Publicity Secretary Prof. Tasneem Alam, City Acting Secretary Nurul Islam Bulbul, Advocate Mashiul Alam and Selim Uddin.

Acting Ameer-e-Jamaat Maqbul Ahmad stated this government is carrying out oppression and suppression on the people of the country. So the people must get rid of this tyrant government.

He called upon the countrymen to be united against the governmentOs atrocities adding. OThe peopleOs government will have to be established by freeing our leaders bringing about the downfall of the AL Government through launching a vigorous mass movement.O In his speech Mr. Magbul Ahmad said achieving victory is difficult. But it is too difficult to preserve it. Despite 39 years long victory of the country we failed to preserve it in the real sense of the term. He went on,O all its achievements have already been tarnished due to its abject failure. We did not chase away the British so as to concede the subjugation of Delhi. But the existing government is out to confine the people of the country in the shackle of the slavery of Delhi O.

In this regard he gave a clarion call on the freedom-loving people of the country to foil this deep-seated conspiracy concertedly.

Referring to the glorious contribution of Jamaat-e-Islami in all democratic movements in the past Mr. Maqbul Ahmad said Jamaat has played key role in all democratic movements. But a quarter is motivatedly reviling Jamaat. But the reality of the country is totally different. Today the people of the country are bewildered as a consequence of tender manipulation and oppression of the ruling party. Even the ruling partyOs own men are not saving themselves from their wrath. Till now 90 AL activists were killed due to intra-party feud. For that reason a former chief justice has termed the government a juggler. Actually they (AL) should remain shame.

In this context, he advised the AL government to return to the right track. Mentioning the governmentOs hypocrisy Ameer-e-Jamaat unambiguously said Awarni League does not work in accordance with its pledge. Acting Ameer of Bangladesh Jamaat-e-Islami Maqbul Ahmad said acute gas, electricity and water crisis is on. The government is blaming the opposition instead of solving this crisis. In this context he asked is it not a democratic country? He also asked does a central leader of any party make a bomb in broad day light? He reprimanded the AL government for not implementing its election pledges though 23 month passed adding. Othe government is doing undemocratic and fascist activities to conceal its abject failure.

With reference to the setting up of Islam in the country the Jamaat chief unambiguously said Jamaat wants to implement Islam, if Islam is implemented it will not be possible for a juggler to play. That is why the government is plotting to wipe out Jamaat-e-Islami from the soil of the country. About the neighbouring country Maqbul Ahmad said we strongly protest the unjust act of the neighbouring country. It is our moral duty.

Blasting the subservient foreign policy of this present government he queried why is it unable to present just demand to the neighbouring country? The people want to know whether they (AL) have signed an argument with the neighbouring country. Everyday Indian BSF is inhumanly killing Bangladeshi people in the border areas.

Dwelling on the grim picture of the economy of the country the Jamaat leader maintained many mills and factories are being shut down due to acute power, gas and water crisis. The rest mills and factories are on the verge of ruination due to the misrule of the ruling party.

But the government is blaming the previous governments including the 4-party. After its 2-year rule the AL government is still accusing the past governments of the above grim economic condition. In this regard he questioned how will they stay in power if they continuously impose allegation on the past government?

Castigating the Awami League government for gagging the press he said even they (AL) are not allowing the opposition parties to hold peaceful programmes like human chain. The police are raiding the offices of the opposition parties. In this connection he urged the government party to shun revengeful politics.

Regarding the present National Parliament Acting Ameer-e-Jamaat bitterly criticized the government for showing undemocratic attitude to the opposition. Instead of the parliament they (AL) want to implement its evil design keeping gun on the court. They want to revert to the 72 constitution. It is apparent from their activities that no problem will remain if the country reverts to 72 constitution.

The existing government totally failed to contain the price hike of essential commodities though it piedged that if voted to power they will keep the essential commodities at a tolerable level. During the last election they piedged before the people of the country that they would reduce the price of rice at 10 taka and provide employment opportunities for all the people of the country.

With regard to the ban on religion-based politics he expressed grave concern over the governmentOs intrigue to ban religion based politics through returning to 72 constitution. India is a secular country. If there are religious parties like Jamaat-e-Islami, Muslim League and BJP in India, why will religious parties not be able to do politics in Bangladesh? The people will never accept such one-party decision. They want to bring secularism instead of faith in Aliah in the constitution. The people can never accept it.

He mentioned that they would unitedly confront the governmentOs evil activities depending on Allah. Referring to the ruling partyOs target for Jamaat-e-Islami the Jamaat chief emphatically said that the Awami League government has first targeted Jamaat so as to stamp out Islam from the soil of the country.

OWhen Awami League assumed power in the post independence period, it excluded the verses of the Quran and Islamic terminology. They are hatching machination to destroy Islam not only opposing Jamaat-e-IslamiÖ, he said.

Before concluding Acting Ameer-e-Jamaat warned the ruling party adding if it plots against Islamic veil, Islamic education, Madrasah etc, it must face the catastrophe in the long run.

One day truth will be exposed. Those who were involved with the missing of Zahir Raihan are responsible for the killing of intellectuals.

He demanded of the government to unmask the real culprits behind the killing of intellectuals on 14 December.

ATM Azharul Islam was speaking at a discussion

meeting as chief guest in Dhaka on 14 December. Jamaat Dhaka City organised the meeting Presided over by Acting City Ameer Hamidur Rahman Azad MP the meeting was also addressed by Central Publicity Secretary Prof. Tasneem Alam, Acting City Secretary Nurul Islam Bulbul and Assistant City Secretary Maulana Abdul Halim.

At the out set of his speech Mr. Azharul Islam described the incident of conflagration in a garment factory at Saver on the outskirt of Dhaka city adding. OThe country is for all. If industries and factories of this country are destroyed we all will be affected. O He said 70/80 percent of the income of the export has come from the garment sector. In this regard he stressed the need for identifying the persons who are inciting behind creating instability in Garment sector. He exhorted the government to refrain from merely

blaming anybody.

OOnce jute was a golden fibre of the country, But it is Awami League government which destroyed this jute setting fire to the jute mills just after the Independence war. That Awami League which is now in power is carrying out conflagration in garments of the country. A deep-rooted conspiracy is being hatched to ruin countryOs garment sector as the jute sector was destroyed shortly after independence, he

Acting Secretary General demanded of the government to form a probe committee to identify the real culprits rising above the party and opinion instead of blaming any body. He said garment owners claimed that laborers were not involved in this incident. The outsiders were involved. In this context he questioned who are outsiders? Why is the government not finding out the outsiders though it can do every thing? Has the government any weakness in this connection? He called upon the government to nab the persons behind the curtain adding Ootherwise the government will have to bear all the responsibilities for the above.O

Mr. Azharul Islam sald independence started on 25 March, 1971. Those intellectuals who were killed on 14 December, thought to stay in the country safe till that time. On 12 December Indian force took the control of the country. Despite 40 years of independence the nation could not know as to who killed the Intellectuals on 14 December.

After Independence Awami League were in power for three and half years. At that time even a case was not filed in connection with this incident. After 25 years case was filed in 1997. Where had Awami League problem to file even a case though it was in power immediately after independence? he enquired.

He went on, on 30 January, 1972 Zahir Raihan was missed at Mirpur. At that time which party ruled the country? Why was Zahir Raihan missed after achieving victory? He also enquired. Every year when the day approaches, function is held, floral wreath is placed on the foot of Shahid Minar and is wept in memory of martyr intellectuals. But any measure to hold trial has not yet taken.

He asked who obstructed the holding of the trial. He asserted trial in connection with the killing of the intellectuals was not held because if trial is held many unknown information will be exposed. So far they are more powerful. For this nobody dared to hold trial of the killing of intellectuals.

Terming the Intellectuals asset of the nation ATM Azharul Islam said they work for the well being of the nation. They make remarks when they need to say for the welfare of the nation. During the 4-party alliance government many intellectuals distributed counsel. Where are now they? Did their counsel disappear? Did they sell themselves anywhere? Or are they playing silent role about eve-teasing, providing corridor in the name of transit, the price hike of essential commodities, leasing sea port to the neighburing country, the rampant killing? he questioned with profound concern. Some intellectuals are pushing the country towards disaster selling their counsels. In the end Acting Secretary General ATM Azharul Islam entreated all to be united against the governmentOs atrocities sinking all differences. Addressing the meeting Prof Md. Tesneem Alam narrated the killing of Intellectuals adding Intellectuals were the greatest sons of the soil of the country. langladesh Jamaat-e-Islami staged demonstration throughout the country protesting the digital vote rigging in the national election on 29 December, 2008, Jamaat Dhaka City organised a rally where Acting Secretary General ATM Azharul Islam was present as chief guest.

He said since assumption of power the present Awami League (AL) government has been violating human rights. When the term of the AL government will be completed, its trial will be held by its own made law.

ATM Azharul Islam asserted this government did not come to power getting peopleOs mandate. So they (AL) have no headache to solve peopleOs problems. In this regard he branded the AL government which assumed power through a deep-rooted conspiracy in a blue-print election, enemy of the country, the people as well as of democracy.

OThere is no alternative to build up a vigorous mass movement in order to bring about the downfall of this government, O he said.

sensing conspiracy we participated in this farcical election. Former General Secretary of AL Abdul Jalil and a key ally of Mohajote government Jatiya Party Chief Ershad admitted that a digital vote rigging was held in the last election. A great proof of this intrigue is that the government, who bagged 266 seats in the last parliamentary polls, is afraid of the people and mass movement. Had it been elected, it would not be afraid of the oppositionOs movement.

Bitterly criticising the present government for formulating the proposed education policy Prof. Emazzuddin Ahmed strongly said that hopes and aspirations of the majority people of the country have not been reflected in the proposed education policy. But that standard has not been protected in the proposed education policy. In this regard he also accused the Awami League government of introducing a secular education policy. In this policy religious education has been ignored. Moral education is completely absent here. So this education policy can ot be beneficial for the mass people.

Prof. Emazzuddin Ahmed stressed the need for holding an open discussion on the proposed education policy in the National Parliament. In this context he opined, good education is a must for attaining efficiency and flourishing spirituality.

Maulana Mohiuddin Khan called upon the government to amend the proposed National Education Policy-2010 Ootherwise we must give stern programme against the present AL government, O he said. Speaking at the convention Principal Maulana Zainul Abedin demanded ilmmediate removal of Islamic Foundation Director General. He also demanded of the government to arrest him and give exemplary punishment to him forthwith.

WAR CRIMES TRIAL IS NOT IN LINE WITH ROME STATUTE

Many of the finer aspects of the Prime MinisterOs UN General Assembly (UNGA) speech were tarnished by her mention of certain points that are personal or propagandist in nature. It made her speech, which was meant to represent the whole nation, slightly parochial. Some of her unfounded comments regarding war crimes trial surprised people. She proclaimed that the International Crimes (Tribunals) Act, 1973, amended in 2009, is in line with Rome Statute. But it is not at all true according to the ongoing discourses nationally and internationally. Many people assumed that Prime Minister deliberately made such statement. This was presumably inserted into her speech by a group of people associated with war crimes trial, whose intentions are to hold trial by any means through manipulation and bypassing proper course of action. The Prime MinisterOs speech at UNGA was used as an opportunity to meet their goal. Their strategy stained the virtue of her speech, but falled to conceal the fact as it is well known to the experts at home and abroad that the War Crimes Act of Bangladesh is inconsistent with the Rome Statute of the International Criminal Court in many aspects. Particularly, It became obvious to all in light of the ÖWar Crimes CommitteeO of OInternational Bar AssociationOs publication of a review report on War Crimes Act. 1973. It may be mentioned here that the War Crimes Committee of International Bar Association completed the review on the request of human rights group of the British Parliament, After reviewing the Act, the War Crimes Committee put forward 17 recommendations. The first point of the recommendations was regarding the definition of War Crimes. The committee described the definition of OCrimes against peaceO and OCrimes against humanityO as disputable and the proposed amendment to it in line with international regulations. The committee raised objection with regard to the phrase Osuperior officerO in section 4 of the Act, as it is contradictory to Article 28 of the Rome Statute. Therefore the committee proposed two amendments in this regard.

Moreover, according to the Committee, the rule concerning the absence of Judges in the Act is inconsistent with the recent trend in the war crimes trial and contrary to the transparency of the tribunal. It recommended that the trial should be stopped in the absence of any judge.

In the War Crimes Act, there is no option for raising any objection by anyone about the appointment of judges or chairman of the tribunal. Opposing this regulation, the committee opined that the tribunal must be neutral and it should pay attention to the objections raised by any side

involved

The committee proposed annulment to subsections 5 and 7 of section 8, related to the investigation process. It also suggested revoking subsection 18 of the same section. It suggested amendment in subsection 11 (2) in accordance with international standard. The issue of self-confession by the accused and witness should be transparent and credible under the law, the committee recommended. Furthermore, subsection 10 (1) (D) of section 10 was also proposed to be amended.

The committee suggested some corrections in section 12 regarding the legal representation of the accused. It also disagreed with and suggested to repeal the death penalty mentioned in section 20 (2). Similarly, they suggested amendment in section 21 regarding appeal.

The most noteworthy recommendation of the committee was with reference to the issue of witness. Newspaper report, photograph, film, tape recording and such other things have been considered as valid evidences in the War Crimes Act, 1973 of Bangladesh. The committee disagreed with this notion and recommended complete annulment of the rule. It is true that this rule, i.e., section 19 (1) should be abolished if the trial is to be considered acceptable internationally.

In the last point of their 17-point recommendation, the committee suggested the inclusion of article 54 of the Rome Statute with regard to the responsibility and power of the prosecuting authority and article 55 relating to the rights of the suspects.

The recommendations of the War Crimes Committee blotted the Act legislated by the government, However, since the government has ratified the Rome Statute, in no way it can repudiate the same. Under the circumstances, the government seems to be at a cross road, in a crisis situation. On the one hand, there is no moral and legal ground to hold the trial of war crimes in Bangladesh and on the other hand if the government holds the trial conforming to the recommendations, the intended political agenda will not be achieved. Hence, a quarter within the government wants to conceal the severe flaws in the Act so as to use it as a ploy to fulfill their political interest. To meet this end, the issue of war crimes has been brought into the speech of the Prime Minister. However, the political observers opine, it was totally unfair to use the Prime MinisterOs UNGA speech in such a reckless manner to implement the mean political agenda.

Immediate & unconditional release of Jamaat leaders and activists demanded



Acting Secretary General of Jamaat-e-Islami ATM Azharul Islam addressed a press-conference at Jamaat central office on 29 October, 2010. The full text of his speech reads as follows:-

"Dear Journalist Friends,

Assalamualikum Wa Rahmatullah,

You are all aware of the fact that police illegally arrested and detained 20 Jamaat-e-Islami leaders and activists including its Assistant Secretary General and President of Shramik Kalyan Federation Professor Mujibur Rahman, assistant secretary of the Federation Shafiqul Alam, publicity secretary of the organization Advocate Abdul Hai and Mirpur police station (west) Jamaat-e-Islami unit Ameer Mahfuzur Rahman from the capital's Mirpur area on 28 October, 2010. We vehemently condemn and protest the unjust arrest.

28 October was the Paltan carnage day. On that day in 2006, terrorists belonging to Awami-led alliance carried out a barbaric attack on a peaceful rally of Bangladesh Jamaat-e-Islami at North gate of Baitul Mokarram Mosque and heinously murdered six men on the spot with oars and sticks injuring hundred others. Many of them were maimed and living a miserable life now.

Mr. Habibur Rahman Mridha was one of the Shuhada (martyrs) on that day. He was a leader of Shramik Kalyan Federation. Habibur Rahman lived at Mirpur and his family lives there now. A Dua Mahfil was arranged at the party office of Mirpur (west) unit Jamaat for the salvation of the departed soul of Habibur Rahman. Assistant Secretary General of Jamaat-e-Islami and President of Shramik Kalyan Federation Prof. Mujibur

Rahman, Assistant Secretary of Shramik Kalyan Federation Shafiqul Alam, Publicity Secretary of the organization S. M. Abdul Hai went there to join the Dua Mahfil. Wife, son and daughter of the Shahid (martyr) Habibur Rahman were also present there. It wasn't any kind of secret meeting. But police suddenly entered there and seized some books and raided the office. They arrested 20 leaders and activists present there including thana unit working council member Tajirul Islam and Shahid (martyr) Habibur Rahman's son Rubel Mridha, who is a student of class ten.

The leaders and activists were arrested illegally even though there is no warrant against anyone of them. After arresting them it is being propagated that some bomb-like substances or bomb making materials and many Jihadi books were found there. Even though it is a fact that leaders and activists congregated there to hold prayer for a Shahid (martyr) and condole his family, propaganda is being carried out that bomb like substances were found with them. Nothing can be a greater lie than this. The government is indiscriminately using police to spread falsehood shamelessly to gain political interests. It is nothing but a plotted drama staged on 28 October at Mirpur to divert the public attention from the ongoing incidents of infightings and brutal killings by the pro-government men.

There is no precedence of finding any bomb or bomb-like substances with the leaders and activists of

Jamaat-e-Islami, Shramik Kalyan Federation or any other front organizations of Jamaat-e-Islami. Jamaat does not believe in and is not involved in the politics of arms and terrorism. So, there is no question of finding any bomb or bomb-like substances with Jamaat leaders and activists. The propaganda about it by police is totally false and baseless. Police resorted to this false propaganda so as to justify their illegal arrest.

Police said that many jihadi books have been rescued from the party office of Mirpur (west) unit of Jamaat-e-Islami. What is a jihadi book? The government is calling all Islamic books as jihadi books. Have they imposed ban on these so called Ojihadi bookO or Islami book? Is there any list of jihadi or Islamic books that are banned by the government? None of the books found in the Jamaat office at Mirpur is banned. An illegal false propaganda is going on in this regard. Command for Jihad can be found in many verses of Holy Quran and Hadith. Does the government intend to ban those? What is the reason behind the propaganda using the term 'Jihadi book'? In many books of the Communist party revolution, even armed revolution is recommended. Communist party men keep those books. Then what is the problem in keeping 'Jihadi book'? The government's anti-Islamic mentality has been clearly revealed from this issue. The government has virtually targeted the Quran by this. We demand of the government to stop the false propaganda in the name of 'Jihadi book'.

Journalists Friends,

Just after assuming power the government started to carry out inhuman repression on Jamaat-e-Islami illegally. Many Jamaat-Shibir leaders were arrested. The party offices of Jamaat were raided every now and then. Even the central office of the party was searched three times. Dhaka city unit office was searched several times. District and upazilla unit offices were also searched. Under the circumstances, is it believable that some bombs or bomb-like substances could be found in a office of the party located in the city? Would a party keep such materials in its office when the government is conducting an all out mis-campaign against it? This is absolutely unbelievable proposition.

Nothing objectionable could be found from any Jamaat office across the country except the Quran, Hadith and Islamic literature. There is no precedence of finding any arms or explosives in any of its offices. Certain quarters in the country ceaselessly are carrying out false propaganda in their bid to mislead the people for gaining political interests. They could not prove anything before and the plotted drama staged in Mirpur would also prove false, Insha-Allah.

All of the twenty leaders and activists arrested from Mirpur are totally innocent. Now the police is taking initiatives to file false case against them. Already many false cases were filed against hundreds of Jamaat leaders including its Ameer, Nayeb-e-Ameer, Secretrary General and two Assistant Secretaries General. Now some more leaders and activists detained in 28 October have become victims of the government conspiracy. We demand of the government to stop such conspiracy and urge it to release all the detained leaders and activists.

Need for the Guidance of Allah

It is an undeniable fact that the source of all knowledge is Almighty Allah Who made this universe and created man to populate it. Who else except Him can know the realities of this universe and who else possesses the knowledge of human nature and its true elements save Him alone? The Creator alone knows His creatures. The creatureOs awareness is circumscribed by what has been revealed to him by the Creator, for the creature has no independent means of his own to get at the truth.

In this connection, the difference between two kinds of things must be fully grasped so as to avoid fallacy in discussion. There are things which you can perceive through the senses, and having gathered a body of knowledge by means of senses you can proceed to classify this information with the help of reflection, argumentation, observation or experimentation inorder to deduce laws from it.

For information on this category of things, no revelation from heaven is needed. This is the province of your

personal discovery, exploration, meditation, reflection, research and deduction. It has been left to you to explore the world around you and discover forces which operate in various things and understand the laws under which these things function so that you may stride forward along the path of development. Nevertheless, in this matter, too, your Creator has not deprived you of His help.

All along the course of history, Allah has been unfolding before you, though imperceptibly, His created world through an evolutionary process. He has, opened up new vistas of knowledge before you, and at certain points in history. He has inspired men to invent a new thing or to discover a new law. The fact remains, however, that in this domain man must gather knowledge by himself without requiring the help of a Divine Messenger or a Divine Book. Man has been endowed with all resources to collect the requisite information in this sphere.

The second category of things is transcendental, beyond the reach of our perception; things which we are powerless to comprehend; things which cannot be weighed or measured

by scales, nor discovered by pressing into service any of the instruments of gaining knowledge which we have at our disposal. The theories of philosophers and scientists on this subject are mere conjectures which do not come under the purview of knowledge, These things are ultimate Realities and rational theories about them cannot be taken as definitive even by the expounders of these theories. If the authors of these theories possess any awareness of the bounds of their limited knowledge, they cannot have faith in the validity of their notions, nor can they call upon others to believe in them.

Need for Following the Precedent of the Prophets (Peace be on them)

Knowledge in this sphere is obtained through the Guidance of Allah, for Allah alone is aware of realities. Allah vouchsafes this knowledge to man by means of Revelation which is transmitted to none but the Prophets (peace be on them). Never has Allah published a Book and, having distributed it to each individual, told him to study it and ascertain for himself the reality of his own existence and that of the universe and to realise his role in the practical world in the context of this reality. Allah has always appointed the Prophets (peace be on them) to convey this knowledge to man, so that the Prophets (peace be on them) should not rest content with the mere propagation of their mandate, but drive it home, demonstrate it in action, recall to the right path those who defy the Divine mandates and organize the believers into a society every aspect of which bears practical evidence of this knowledge.

It is evident from this brief exposition that for Guidance we are wholly dependent upon the character displayed to the world by a Prophet of God (peace be on him). A non Prophet who is a disbeliever in a Prophet is not eligible to be our leader, even though he may be a sage, deeply learned and wise. This is so because such a man does not possess the knowledge of reality and a person bereft of this knowledge is incapable of devising a true and just system of life for us.

Why canOt we obtain Guidance from the Prophets other than Muhammad (peace and blessings of Allah be upon him)?

Let us now take up the questions as to why of all the venerable personages whom we know as the Prophets and all the leaders of religions who conceivably may have been Prophets, we prefer to seek a message from the Character of Muhammad (peace and, blessings of Allah be upon him). Do we suffer from prejudice or is there a reasonable ground for doing so?

I submit that there is a rational basis for this. We certainly acknowledge and believe in the Prophethood of all those


personages who have been named in the Holy QurŌan as Prophets. But, then, information with regard to the teaching and character of none of them has been bequeathed to us by any reliable or authentic sources to enable us to follow their lead. There is not a trace of doubt about the Prophethood of Hadrat Noah, Ibrahim, Ishaque, Yusuf, Moses and Jesus Christ (peace be on them) and we believe in all of them. However, none of the Scriptures revealed to them has come down to us in its original form so that we may benefit from its pristine message. Similarly, the life-history of none of these Prophets (peace be on them) has been handed down by any foolproof and authentic means to enable us to emulate their example in the various spheres of individual and collective existence.

A person who undertakes to prepare an account of the teachings and characters of all these Prophets (peace be on them) cannot write more than a few pages and these, too, entirely with the help of the Quroan for nowhere else is extant authentic material about them except in the Holy Quroan.

In the second century A.D. the Jewish scholars prepared a Jewish Bible with the help of manuscripts which had survived the vicissitudes of time. The oldest copy of this Ö Bible extant now dates back to 916 A.D. Apart from this, no other Jewish manuscript exists anywhere today.

The Jewish scrolls discovered from the cave of Qumran on the Dead Sea are not older than the first and the second century B.C., and even these contain a few scattered fragments of the Bible. The earliest manuscript comprising of the first five Books of the Bible current among the Samaritans was written in the eleventh century A.D. The Greek Translation prepared in the second and the third century B.C. was marred by countless errors. A retranslation from Greek into Latin was done in the third century A.D. By what standard can you adjudge this material as an authentic source of the life histories and teachings of Moses (peace, be on him) and the later Prophets of the Jews?

In addition to the above, there were certain unwritten legends called oral law, current among the Jews. For a span of thirteen or fourteen centuries they remained unwritten until in the later part of the second and the beginning of the third century A.D., a priest known as Yahuda b. ShamOun committed them to writing under the title of OMishnahO. Commentaries on this work by the Palestinian Jewish scholars under the name of OHalakaO and by Babylonian scholars under the title OHaggadaO appeared in the third and the fifth century respectively. The OTalmudO is, in fact, an anthology of these three works. Significantly, authoritative evidence which may reveal the chain of transmission is lacking in the case of all traditions incorporated in these books. (To be continued)

Sino-Pak ties rock-solid

In an effort to consolidate friendly relations with close neighbours in South Asia, the Chinese Premier Wen Jiabao has completed a three-day visit to Pakistan, aimed at further strengthening bilateral ties and expanding cooperation in all areas.

Prime Minister Yousuf Raza Gilani on 18 December hosted a luncheon in honour of his Chinese counterpart Wen Jiabao and members of his delegation.

Prime Minister Gilani, extending a warm welcome to the Chinese premier, said the ties between the two countries were "rock solid" and the two would jointly celebrate 2011 as the year of Pak-China friendship, marking the 60th anniversary of bilateral relations.

Gilani acknowledged with gratitude China's assistance to Pakistan in the 2005 earthquake the Attabad Lake and the recent floods.

He said Pakistan supports the one-China policy and "condemns any attempt to undermine China's sovereignty and territorial integrity".

Gilani said the two countries share the ideals of a safe, secure and prosperous neighbourhood and a region free from strife and conflict.

"We want this vision to be translated into reality," he added. Chinese Prime Minister Wen Jiabao said both countries were good neighbours and had marched ahead through thick and thin together.

He said the relationship had gone beyond bilateral ties and had moved into the strategic sphere.

Jiabao recalled the devastation caused by the floods and said the Chinese people were deeply concerned by the disaster. He assured Pakistan of China's support in the country's agriculture, infrastructure and energy sectors on a sustainable and durable basis.

Jiabao said he was delighted to return to Pakistan after five years and appreciated the hospitality.

He said the two sides would hold a series of events next year to further strengthen their ties for an enduring strategic partnership.

And in a keynote address to the conference, Jordan Os King Abdullah II said Isreall-Palestinian peace talks must be rescued from collapse to ensure regional and world stability.

Turkey government suspends generals linked to coup plot

urkeyOs government has suspended two generals and an admiral linked to an alleged plot to stage a military coup, newspapers reported on 25 December.

The three were named in the probe of an alleged plan to oust the government led by the Islamist-rooted Justice and Development Party (AKP), Newspapers said, adding it was the first time the government had suspended serving officers.

The trial of around 200 members of the military implicated in the 2003 plot is expected to start December 16.

Conspirators are accused of planning attacks on mosques and to provoke tension with neighbour Greece, hoping to trigger instability and setting the stage for the ousting of the government.

The government is seen by some sections of the military as favouring Islamisation while the military views itself as the guardian of the secular foundations of the country.

Egypt to opposition party shut out of parliament

ligyptOs largest opposition group has not won a single seat in the first round of parliamentary elections with more than 40 percent of contests decided.

The Muslim Brotherhood, which has alleged rampant fraud in vote, controls a fifth of the seats in the outgoing parliament. The leading opposition group suffered the dramatic setback after years of government crackdowns, especially during the election campaign. The Brotherhood says it is weighing its next move and may boycott runoffs on Dec. 5, when 26 of its candidates are slated to compete. Official results for the first round, announced on 1 December, gave President Hosni MubarakOs ruling National Democratic Party 2009 of 508 seats. The round decided 43 percent of seats.

Iraq approves new govt with Maliki as PM

raqOs parliament approved Prime Minister Nuri al Maliki and his new government on 21 Dec, nine months after an inconclusive election left politics in limbo and delayed investments to rebuild the country after years of war.

Lawmakers voted Maliki and a new multi-party slate of ministers into office, elevating Oil Minister Hussain al Shahristani to deputy prime minister for energy, and leaving in place Kurdish veteran Foreign Minister Hoshiyar Zebari.

Highlighting the ethnic and sectarian divides the pervade the war ravaged country, parliament had to postpone the vote on 20 December after last-minute factional disputes and political horse-trading over posts delayed the governmentOs formation.

As Maliki read out the chosen ministerOs names one by one, parliament speaker Osama al Nujaifi scanned the chamber for raised hands and said approved by the majorityO each time. The speaker did not ask for a show of hands from those opposing the candidate of abstalning from the vote.

Jordan names first woman chief district attorney

fordan on 8 Dec. appointed a woman as chief district attorney of the countryOs capital, marking the first time a woman has held a top prosecutorOs post in the pro-American Arab kingdom.

Ihaan Barakat, a 46-year-old judge and mother of two, will assume her post on Sunday, Jordan Os Judicial Council said in a statement. The council, which is the highest judicial authority in Jordan, said Barakat will lead a group of 60 prosecutors- which includes only one other woman- in the capital of Amman. Only male district attorneys serve in other districts across Jordan.

Barakat, who has served as a judge on JordanÖs appeals court for the past eight years, called her appointment Ogood news for women, not only in Jordan but across the Arab world, because it shows that thereÖs no post confined to men in our societies. O

PALESTINE

Palestinians seek unilateral statehood recognition Direct Mideast talks collapse as US freeze bid fails

The Palestinians' Plan B -- an alternative to the elusive peace deal with Israel -- is gradually taking shape: convince as many countries as possible to recognize a Palestinian state in the West Bank, Gaza and East Jerusalem, and use that to lobby the United States not to veto recognition by the U.N. Security Council.

The issue suddenly became more urgent late 7th December when U.S. officials said they had abandoned efforts to get Israel to reinstate a West Bank settlement construction slowdown, concluding that was not the best way to restart the talks. The Palestinians have said they would not resume negotiations without construction curbs.

With efforts deadlocked, Brazil and Argentina have recognized "Palestine," expected to be followed by Uruguay next month, the result of what a senior Palestinian official described as months of campaigning.

SUDAN

Sudan troops kill 40 Darfur rebels in new offensive

ludan says government troops have killed at least 40 rebels in a new offensive in the countryÖs troubled Darfur region.

Army Sopkesman Capt. Khalid Sawarmy says the rebels were killed during fighting on 24 December when army forces attacked joint positions of two rebel groups the Justice and Equality Movement and the Sudan Liberation Movement.

The spokesman, whose comments were carried on 25 Dec. by the official Sudan News Agency, says three soldiers also died and 13 were wounded in the fighting.

DarfurOs most powerful rebel group, the Justice and Equality Movement, said Sudanese soldiers attacked rebel positions in North Darfur on 23 Dec. near Dar al-Salam, south of the regional capital of El Fasher, JEM said three rebels were killed and eight wounded.

The International peacekeeping mission in Darfur said it was gravely concerned about the reported clashes, and urged those fighting to allow humanitarian access to civilians in the area.

Kosovo PM Claims victory, rivals refuse to concede

Hosovo waited for offecial results on 13 December to confirm Prime Minster Hashim ThaciÓs claim of victory in the first general election since independence from Serbia, amid accusations of some vote mainpulation. ThaciÓs rivals did not concede, citing suspicions of irregularities in two of

his stronghold towns. Supporters of both ThaciOs PDK Party and the rival LDK, a former coalition ally, celebrated on 14 Dec. night with firecrackers and honking horns as they drove around town.

OHopefully, things will get better. But it was strange to see both parties celebrate. We Albanians are imptient. And thereOs not much to cheer about at a time when we do not control a part of the country,O said Belul, a newspaper vendor. Kosovo, where ethnic Albanians made up 92 percent of the population of 2.2 million, declared independence from Serbia in 2008 but Serbs still dominate the north of the country.

Voting took place in a generally calm atmosphere except for minor incidents in the north. Western monitors were expected later on 5 Dec. to assess whether the elections were free and fair. In 1999, NATO Forces bombed Yugoslavia for 78 days to stop its Serb-dominated army waging ethnic cleansing in Kosovo.
